- Position paper Management of smoke arising from prescribed burning of vegetation is currently under revision.
- The Tasmanian Vegetation
   Management Policy 2017 is under
   review and will include extensive
   stakeholder consultation and end
   user feedback.
- Red Hot Tips Advisory Group has commenced a recruitment process.
- Hobart and Southern FMAC recommendations were endorsed.
- The SFMC met with Central Highlands landowners at Campbell Town on 24 May 2024 to discuss fire permits, use of local champions in campaign fires and the machinery operations guidelines.

### FMAC NEWS

We have come to the end of the 1st round of the FMAC meetings. Thank you for your participation and contribution.

Feedback on the draft FMAC Induction Manual has been extremely positive. You will receive the revised 2nd draft soon. The manual is on schedule for submission of the final draft to the SFMC in September.



All FMAC Bushfire Risk Management Plans are required to be submitted to the SFMC by 30 September 2024 for approval. SFMC will work with FMAC Chairs, BRU Planners and BRU GIS staff on this.
