# Fire Prevention at Forest Operations Procedure updated

The Tasmanian Forest Industry Fire Management Committee (FIFMC) has endorsed changes to the Fire Prevention at Forest Operations procedures and equipment audit form for the upcoming 2023 fire season which commences October 1.

The FIFMC was established in the early 1990s with an objective to minimise the incidence of wildfire resulting from forest operations and to ensure compliance with relevant regulations. Endorsed by the Tasmanian Fire Service, procedures outline minimum fire equipment requirements and procedures to follow to reduce the risk of fire in both high and low risk hazard forest activity.

## **SFMC Update**

The **FMAC Review** has been accepted by SFMC and will soon be sent to all FMAC Members. Sincere thanks to all who contributed to the FMAC review. The review highlights the need for change and improvement, and Pep and the team will continue



this with further consultation with FMACs on a **FMAC Handbook**. The SFMC have resolved to progress to the State Fire Commission the recommendation from the FMAC Review to implement **6 FMAs** (Hobart, Flinders Island, King Island, Northwest, Northeast and South).

Pep has listened and taken forward your views on TFES Reform and the TFES Draft Bill. Engagement and communication with the Ministers office and the Fire Service Act Reform Steering Committee continues. The SFMC and other submissions can be found via the link below. John Atkinson (TFGA SFMC), Pep Turner and I were at the Minister's Roundtable where the proposed fire service levy models were abandoned, and a working group established. The SFMC is providing advice to the Minister and is at the table to advocate for reform. https://www.fire.tas.gov.au/reform/submissions/

To improve communications between the SFMC and FMACs, a feedback structure will be implemented and trialled in 2024. This will include **BRMP Implementation Status Reports** and **FMAC messages to SFMC**. Many thanks to those who were involved in **updating BRMPs**. These were approved at a SFMC Extraordinary meeting on the 23 October 2023, and are available on the SFMC website and FMAC SharePoint.

In other news, the **Strategic Coordination Group** met and discussed several projects including High Risk Lightning and Fixed Cameras; the **Machinery Operations Guidelines** Working Group reviewed the Guidelines and the SFMC are working with TFS on wording used in alerts, and; **Permit Officer** Rescindments/Recommendations for October and November 2023 were approved.

On behalf of the SFMC, I would like to thank all FMAC members for your continued support during a challenging year and wish you a safe and happy holiday season.

Red Hot Tips is a free one-stop service for farmers and rural landowners. The program educates, engages and supports farmers and landholders in rural Tasmania to actively manage their bushfire risk; encouraging collaborative vegetation fire management and ecological sustainability across the landscape.

Program Facilitators have been working with several landowners and stakeholders from across the state over the past few months to ensure burns could be achieved when the conditions were suitable.

RHT has been working with Tasmanian Women in Agriculture empowering their members, and other interested participants, to manage their bushfire risk. Burn plan workshops were held in Rowella and Kettering.
